Happy New Year, Diplomates! Let's hope for a healthy and productive 2013.

An interesting legal decision involving 2 FDEs was issued In December 2012, and it may behoove us to be aware of it. Miller vs. State of Florida, the District Court of Appeal of the State of Florida, reversed a decision by the trial court to allow handwriting experts to "bolster" their testimony by describing the peer review process. hile this decision only applies to the immediate case, many FDEs have found it nevertheless unsettling, especially in light of the preliminary findings by Professor Moshe Kam that peer review reduces FDE error rates to 0.0%.

ABFDE is proceeding with elections this year to replace one Director, and replace two Directors whose terms are expiring in July. lease watch your email boxes for election information.

ABFDE is arranging pilot testing on the ACT updated written test questions at the ASQDE meeting in Indianapolis, on Saturday, August 17 prior to the start of the meeting on Sunday, August 18. The Board is requesting that attending Diplomates participate in this very important project. Of course, recertification points will be awarded! Please contact Kirsten Singer if you intend to participate.

The National Institute of Standards and Technology (NIST) is planning to host a 2-day symposium on measurement science and standards in forensic handwriting analysis, June 4-5, 2013, on the NIST campus in Gaithersburg, Maryland. I agreed to represent ABFDE as a co-sponsor of this symposium with NIST and similar professional organizations, such as

# Continuing Education: Logical Inference & Reasoning, and Typography

The Canadian Society of Forensic Science (CSFS) Document Section recently hosted an excellent three-day FDE workshop in Ottawa.

Part I covered the practical applications of logical inference and reasoning for FDEs (led by Brent Ostrum), an intensive exploration of concepts relating to logical inference and likelihood ratios (LRs) for the evaluation of evidence. Logical inference is ultimately the <u>only</u> way forward for any forensic discipline, and a great many problems from the FDE domain have the potential to be addressed by this approach, but it must be <u>properly applied</u>. Diplomates should seize any opportunity to educate themselves about LRs, as other countries (and their courts) are already actively pursuing and using them. An extensive list was provided for further reading. Future workshops in this important area, hosted by CSFS and other bodies, are anticipated.

Part II given by Peter Tytell was an extensive review of typography for FDEs, exploring the fundamentals of typography and their practical applications in FDE. Encompassing the different systems used internationally for type measurement, typestyle classification, as well as nomenclature, this review was of equal value to trainees and experienced FDEs alike. Peter's knowledge in this area is vast and continuously expanding, and as such he is an extremely valuable resource for the discipline. Peter also provided a thorough list of references and resources to update our libraries. Diplomates should note that an added benefit of workshops hosted by the CSFS is that there is often little or no cost to attend, and as such they represent terrific value for money. If you see them advertised, please do consider attending. ABFDE Certification Points are also usually awarded (15 points for this particular event).



## Typewriter Music

A January 2013 discussion on the Docexam\_L List about this song provided the inspiration for this article.

Leroy Anderson (1908-1975) was a composer of pops orchestral music, mainly composing short, happy pieces.

In 1950, Anderson wrote a piece called "The Typewriter", which featured a solo on a mechanical typewriter. The Typewriter received its first performance when Leroy Anderson conducted the one minute and forty-five second song for a Decca Records recording session in 1953. Shortly after, a full band arrangement was

published by Fred Werle.

Since then, The Typewriter has been recorded and performed many times, and has featured many live 'soloists', including rock group Aerosmith's lead singer Steve Tyler, who played the song in a special 1999 Boston Pops concert. Anderson studied at Harvard, working to-


wards a PhD in German and Scandinavian languages. Anderson's first work was *Jazz Pizzicato* in 1938, but at just over ninety seconds, the piece was too short for a three-minute 78-RPM single of the period. It was suggested that a companion piece be written and thus Anderson wrote *Jazz Legato* later that same year. The combined recording went on to become one of Anderson's signature compositions.

In 1942 Anderson joined the U.S. Army, and was assigned to Iceland as a translator and interpreter. Later in 1945 he was assigned to the Pentagon as Chief of the Scandinavian Desk of Military Intelligence. But his duties did not prevent him from composing, and in 1945 he wrote "The Syncopated Clock" and "Promenade." Anderson was a reserve officer and was recalled to active duty for the Korean War. In 1951 Anderson wrote his first hit, "Blue Tango," earning a Golden Disc and the No. 1 spot on the Billboard charts.

His most famous pieces are probably "Sleigh Ride" and "The Syncopated Clock". In 1950, WCBS-TV in New York City selected "Syncopated Clock" as the theme song for *The Late Show*/ the WCBS late-night movie. Mitchell Parish added words to "Syncopated Clock", and later wrote lyrics for other Anderson tunes, including "Sleigh Ride", which was not written as a Christmas piece, but as a work that describes a winter event. The Boston Pops' recording of it was the first pure orchestral piece to reach No. 1 on the Billboard Pop Music chart. From WIKIPEDIA.COM.






## THE BIG NEWS OF 2012:

## Lectures, hands-on sessions and live demos comprise four-day program

Rochester Institute of Technology will host a highly specialized seminar from April 23 to 26 to help forensic document examiners successfully identify fraudulent documents.

Attendees will learn about the latest in traditional graphic arts processes and digital printing technologies that are used to determine the authenticity of currency, stamps, passports and other legal papers.

The seminar is targeted toward questioned document examiners, forensic document examiners, forensic scientists, criminologists, fraud investigators and government employees who work in or with crime labs.

The Printing Process Identification and Image Analysis for Forensic Document Examiners seminar will be held on the RIT campus. There will be lectures and live demonstrations of the newest image capture and analysis systems. Attendees will learn how to compare documents produced by traditional printing processes with fraudulent replicas produced by non-impact technologies such as inkjet, electrostatic printing, dye diffusion, laser printing, xerography and thermal transfer.

Topics will include conventional printing processes, conventional process image structure, non-impact printing, paper substrates, inks and image analysis:

The seminar's instructors are Tom Jay, vice president of SICPA Securink USA; Milton Pearson, who has a career spanning 30 years as an imaging scientist at RIT, Majid Rabbani, a Kodak Research Fellow and head of the image compression and video processing technology areas in the imaging Science division of Eastman Kodak Co.; David Tobin, president of Foster & Freeman USA, and Owen Lang, senior applications engineer at Foster & Freeman USA. The company designs and manufactures systems for the examination of question documents, latent fingerprints, trace evidence and shoe prints. Rounding out the list of presenters are Mike Caffrey, business development manager for security products for Appleton; Amanda Moffett, document analyst with the U.S. Secret Service who specializes in document authentication and instrumental analysis; and Joseph Stephens, a document analyst with the U.S. Secret Service who conducts ink, paper and toner comparisons and document authentication examinations on an array of submitted documents.

## IN HISTORY...January — March

JANUARY 12, 1895: PRINTING AND BINDING ACT OF 1895 PROHIBITED THE COPYRIGHT-ING OF ANY GOVERNMENT PUBLICATION.

JANUARY 23, 1849: A PATENT WAS GRANTED FOR AN ENVELOPE MAKING MACHINE.

JANUARY 30, 1883: JAMES RITTY AND JOHN BIRCH RECEIVED A PATENT FOR THE CASH REGISTER.

FEBRUARY 12, 1983: THE CIRCULAR THING THAT KEEPS THE PIZZA FROM HITTING THE INSIDE OF THE BOX TOP (CALLED A "PACKAGE SAVER") WAS INVENTED BY A GUY FROM NEW JERSEY.

FEBRUARY 20, 1872: LUTHER CROWELL PATENTED A MACHINE THAT MANUFACTURERED PAPER BAGS.

FEBRUARY 24, 1857: THE FIRST PERFORATED UNITED STATES POSTAGE STAMPS WERE DELIVERED TO THE GOVERNMENT.

MARCH 2, 1861: THE "PATENT ACT" OF 1861 INCREASED TERM OF A PATENT GRANT FROM 14 TO 17 YEARS; NOW IT IS 20 YEARS.

MARCH 4, 1955: THE FIRST RADIO FACISIMILE OR FAX TRANSMISSION WAS SENT ACROSS THE (US) CONTINENT.
