

# Aloha My Fellow Diplomates,

for the Board. The courts and legal system continues to raise the bar for standards in all areas of Forensic Science. Starting with the Starzecpyzel decision, our discipline was the first to be affected. While some of the other disciplines may have laughed at us at the time, they soon found themselves targeted next. Our positive response and immediate actions helped lead us to successfully improving our discipline in meeting the



requirements set by the courts. Our efforts have since served as an example for the other disciplines to follow. Laboratory accreditation is becoming more and more a requirement by the courts. The ABFDE has received requests to participate with a joint task force headed by Dr. Linton Mohammed to address an effort to establish a program for the accreditation of small agencies and private practices. The ABFDE has offered our support in these efforts. Diplomates who are trained as ISO accreditation inspectors would be very helpful. At the Board's annual meeting this past March we were tasked with making several important decisions. One of the most difficult was to raise the dues. ## DEMYSTIFYING ABFDE BOARD CERTIFICATION

(Previously known as ABFDE Certification 101)

ver the last six years the Board has hosted many **Demystifying ABFDE Board Certification** workshops at various conferences and meetings. Since the maiden voyage in Chicago at the MAFS Meeting, we have had the pleasure of over 70+ attendees and many of these attendees have gone on to become active Candidates and/or have completed the process and have attained board certification.

If you do not know about the workshop, I will give you a quick summary. The cost per Attendee was between \$100 and \$125. It was voted by the Board that all monies collected from the workshop fees, minus the workshop attendee costs, as well as the instructor's travel and hotel, would be given to the Organization that allowed us to include the ABFDE workshop in their program.

Six weeks prior to the workshop, each workshop attendee is mailed two original Practical Problems. These two Practical Problems have to be completed prior to attending workshop. They are instructed that their case notes must be highly detailed and must comprehensively cover their thinking process, as well as their examination process. They must also write a complete report using proper (acceptable) wording and are directed to reference/use all SWGDOC guidelines they feel apply. Upon completion of their Practicals, the attendee scans all case notes, work product and reports for both Practicals and then emails those scans to the workshop instructor.

While the attendees are busy working on their Practical problems, the workshop instructor finds ABFDE Diplomates who are already planning on attending the meeting where the workshop is scheduled to be held. When these Diplomates are located, they are "encouraged" to be "Mentors" during the upcoming workshop. The mentor to attendee ratio for this workshop is 1 mentor for every 2 attendees and we have been able to maintain this ratio except for one or two times where we had to have 1 mentor for 3 attendees. The Diplomates who agree to be mentors receive the scanned work products and reports for each of their two attendees about one week prior to the workshop. This is done so they can have time to review their attendee's work product in depth.


During the workshop, the attendees are given the history of the ABFDE, information about the importance of

examiner certification and why one should belong to and be active in "legitimate" QDE organizations. At the end of the morning session, the attendees are given a "sample" written test to take that gives them a taste for what the Written Test will be like in the certification process. After lunch, the group goes over the written test questions and answers and the workshop instructor answers any questions that may have come up during the morning session. After all questions are answered, the large group breaks into small groups; one mentor and their two attendees to whom they were assigned. Each attendee will present one of their Practicals to the mentor in the same manner our Candidates present their work product during their official Oral Panel. Of course the mentor and their attendees are not dressed in business suits or presenting with Power Point, but the environment is made as close to the real thing as possible. The attendee will present his/ her Practical work product and its conclusion to their mentor and when that attendee is finished presenting, the mentor asks questions of the presenting attendee that either involve the practical, the examinations conducted or the theory used during the examination/conclusion process. The second attendee then presents the other practice Practical, giving him/her the same opportunities/ experience with the mentor. This "mock oral panel" as well as the two practice Practicals, are two sections of the workshop that attendees stated were most helpful in relieving their levels of anxiety about the certification process (written surveys were filled out at the end of each workshop).

I am happy to announce that we presently have fifteen (15) Candidates in the certification process and two (2) that should be passing through credentialing process soon. Four of those fifteen Candidates will be participating in their Oral Boards at this year's AAFS meeting!

I sincerely want to THANK our Diplomates who have given of their time, energy and knowledge over the past six years that have made this workshop the success it has been. Without everyone's hard work and participation, this workshop could have never been offered! There are future plans to offer this workshop again, if and when requests come in for it again. So please, please, if you haven't had a chance to participate as of yet, consider saying yes if you get the call. The workshop is a lot of fun!!!!

# CONGRATULATIONS TO JASON LE NEW DIPLOMATE



ason Le is the Lead Forensic Document Examiner at the Treasury Inspector General for Tax Administration, Forensic and Digital Science Laboratory (TIGTA, FDSL) in Beltsville, MD where he has worked since 2013. He received a Bachelor of Science in Biology from the University of Pittsburgh in Johnstown, Pennsylvania in 2000 and a Master of Forensic Science from The George Washington University in Washington, DC in 2002.

Jason began his career in forensic science as an intern at the U.S. Department of Justice, Immigration and Naturalization Service, Forensic Document Laboratory (INS, FDL) in McLean, VA where he was eventually hired as a trainee forensic document examiner. There, he completed a 30-month comprehensive training program in questioned document examination and became a bench examiner for the FDL, which had become part of the Department of

Homeland Security, Immigration and Customs Enforcement. As a Senior Forensic Document Examiner, Jason initially became subject matter expert for cases originating from Eastern Europe. His area of expertise transitioned to the former Soviet republics before he eventually became subject matter expert for cases originating from Middle Eastern countries, working cases closely related to terrorism. Jason also led the FDL Counterfeit Deterrence program, critical feedback providing credentialing agencies regarding the appropriate design of secure identity documents, to include the Passport, U.S. Visa, U.S. Passport Card, Border Crossing Card, immigration entry and exit stamps and state driver licenses.

At TIGTA, in addition to working cases involving employee fraud, tax fraud and threats against Internal Revenue Service personnel and facilities, Jason oversees the Questioned Document Section, assigning casework, reviewing completed cases, assuring that standard operational procedures are being followed and updating policies in accordance with the requirements for ASCLD/LAB-International

accreditation. Jason is also involved in **TIGTA** training Special Agents, teaching a class regularly Questioned Document Examination at the Special Agent Basic Training Course the Federal Law at **Enforcement Training Center.**

andra Miller Raudabaugh grew up in a suburb of Pittsburgh, PA where she eventually enlisted as a Trooper in the Pennsylvania State Police in 1993. Several years later, in 1999, she saw a posting for a trainee position in the Questioned Documents Section of the Harrisburg Crime Lab.

Her interest in the position led her to reflect upon a distant past when she was working in retail loss prevention. Although not part of her duties, she was looking at store receipts to gain a better understanding of store activities. In doing so, she noted anomalies in the signatures on several merchandise return receipts. After a thorough investigation and parsing through past return receipts, a long-time department manager eventually admitted to the forging of signatures over the years and stealing over twenty thousand dollars

from the company through fraudulent merchandise returns. It was quite the discovery for Sandra and the company, unknowing at the time that this would be a springboard in her career.

Hence her initial interest, Sandra accepted the position and transferred into the QD Section where she completed her training in 2001. Throughout her career, her various assignments within PSP had taken her away from and then back to the crime lab where she was eventually promoted and served as the QD Section Supervisor. This is when she decided to apply for ABFDE certification.

On acceptance of the next career promotion however, she had to leave the crime lab once again. Sandra later retired from the Pennsylvania State Police in 2016 with the rank of Lieutenant, but continued her previously established private practice and her pursuit of board certification.

# AAFS CELEBRATES MAUREEN CASEY OWENS, D-ABFDE

aureen Casey Owens graduated from Mundelein College (later incorporated into Loyola University Chicago) with a chemistry major and a math minor. She began her career in 1961 as a Physical Science Aide in the Document Section of the FBI Laboratory. In 1963, she joined the Chicago Police Department (CPD) Laboratory as the only civilian employee in the technical laboratory. Ms. Owens worked at the CPD as a forensic document examiner for 25 years, including 13 years as the head of the documents section.

Ms. Owens is the only person to simultaneously serve as the President of the AAFS (1984-1985) and the President of the American Society of Questioned Document Examiners (ASQDE) (1984-1986). She was a founding member of the American Board of Forensic Document Examiners (ABFDE) in 1977 and subsequently served on the Board of Directors and as Treasurer of the ABFDE.

In 1987, Ms. Owens received the Ordway Hilton Award from the AAFS Questioned Documents Section. In 2008, she received the

Albert S. Osborn Award of Excellence from ASQDE in recognition of her distinguished career and many contributions to the profession of forensic document examination.

Among Ms. Owens' many cases, she helped identify Joe Klein, the *Newsweek* columnist, as the anonymous writer of the novel *Primary Colors*. In 1993, her work helped prove that a purported diary of Jack the Ripper was not authentic. Ms. Owens is the author of numerous published articles and professional papers.

# MEMORIAL—GORDON ROY LLOYD STANGOHR

ordon Roy Lloyd Stangohr passed away peacefully at his home in the **Greenspring Retirement** Center, Springfield, Virginia, on March 10, 2017 at the age of 96. Gordon was born June 29, 1920, on a farm in Winfred, South Dakota, After high school, he received a scholarship to attend Grand Island Business School in Nebraska. Upon completion, he accepted a Civil Service position with the Census Bureau. This opportunity was interrupted with the onset of World War II. He joined the U.S. Army and served in the Pacific Theater from 1942 to 1945, and received many honorable medals.

On July 10, 1949, he was united in marriage to Lois L. Tibben in Santa Monica, California. They were blessed with four children: Linda Marie, Janet Irene, Jerry Allen, and Carol Jean.

Gordon continued his education by attending American University in Washington, D.C. and taking many Science. He obtained the prestigious position as the Director of the U.S. Postal Crime Laboratory in Washington, D.C. With his expertise alongside his co-workers, he helped pioneer Forensic Science by forming a link between science, technology and criminal justice. Gordon's specialty was Forensic Handwriting, whereby, he examined, analyzed and



testified in Federal, State and Military courts throughout the Nation on behalf of the U.S. Government. He also represented the U.S. in their Interpol Convention in Paris. Notably, he assisted in the training of over thirty foreign representatives for international collaboration and forensic development. During his U.S. Postal career, Gordon simultaneously served in the U.S. Army Reserves obtaining a rank of Chief Warrant Officer 4. other professional courses in Forensic After his retirement as Director of the U.S. Postal Service, Gordon continued to use his expertise to instruct future inspectors for the FBI and the Virginia State Crime Lab. With his enthusiasm and background, he ably assisted in creating intense forensic study programs – not stopping until his second retirement at the age of 80.

As for the workshops, I am planning on having 4 half day workshops and a one full day workshop broken up into a morning and afternoon session for a total of 5 workshops. These workshops will be starting on either Sunday or Monday. The workshops and their abstracts are listed as follows:



**Examining Documents Requiring a Multi-Faceted Approach** by D/Sgt. Todd Welch (Michigan State Police). This workshop and following in the footsteps of longtime presenter of this workshop, Brian Lindblom, will focus on disputed documents that by their nature or components are complex and require a combination of examination techniques. The evidence derived from microscopic, infra-red, indentation and other testing will be considered in the context of questions

raised about a document's integrity and authenticity. There will be a lecture format followed by hands-on analysis of various single and multipage documents; working within groups. Equipment will be available for use by the participants. An open discussion of the results will conclude the session.

<u>Covert Communications and Concealment Techniques</u> by Mr. Peter Belcastro (FBI) & Mr. Gregg Mocrzycki (FBI). This presentation

will discuss various types/methods of concealed communications and the role they play in criminal and intelligence investigations. Focus will be placed on the detection, development, preservation, and demonstration of various types of cov-

ert communications that have been encountered in actual questioned document case scenarios. Equipment, chemicals, and other tools utilized during the examination of such cases will be discussed as well as various "offensive forensic techniques" that can be utilized in these Particular types of investigations. attention will be paid to techniques utilized by prisoners to communicate and transmit information secretly; including ways prisoners create and utilize concealments. Hands on exercises will be conducted concerning the creation of various types of concealment tradecraft and the detection of these items.

**The Forensic Examination of Original and Copied Signatures** by Dr. Linton Mohammed. The examination of signatures comprises much of the



caseload of most Forensic Document Examiners. Quite often. the FDE is tasked with comparing signatures that are copies of varying quality.

These copies are generally pdf files, fax copies, or photocopies. This workshop will look at what is lost in the various copying processes with different resolutions in comparison with the original signatures. The strength of opinions in cases involving copies will be discussed. Attendees will examine both original and copied versions of signatures, and discuss their observations in groups or individually.

Forensic Science Research: How to Make Your Proposals Competitive by Mr. Gerry LaPorte (National Institute of Justice). Scientific research is often characterized as basic or applied. Basic research is defined as a system-



atic study directed toward fuller knowledge or understanding of the fundamental as-

pects of phe-

nomena and

of observable facts without specific applications towards processes or products in mind; applied research is defined as a systematic study to gain knowledge or understanding necessary to determine the means by which a recognized and specific need may be met. As well, "Development"

is often associated with research, but is not commonly recognized as a separate function, which is the application of knowledge or understanding, directed toward the production of useful materials, devices, and systems or methods, including design, development, and improvement of prototypes and new processes to meet specific requirements. Undoubtedly, rigorous research and development is the cornerstone of accurate, reliable, and valid methods used in forensic science laboratories. However, gaps can exist when research involving forensic science - an application of various sciences to address matters of law - does not include a rigorous research design or consideration of practical limitations and applicability.

Practical casework in the forensic sciences varies from structured research in a controlled environment, but the need to understand limitations with respect to interpreting data from any forensic analysis is critically important to ensure forensic scientists are communicating their findings and conclusions unambiguously. This can be a challenge when proposing research and applying for grant funding. This workshop is intended to be interactive to share ideas about creating research partnerships, strengthening a research grant application, involving student researchers, and considering research and development that can be integrated into an operational laboratory without a significant disruption to casework.

<u>Deciphering Complex Impressions with Adobe Photoshop</u> by D/Lt. Mark Goff (Michigan State Police). This workshop expands on previous methods of tracking sourced impressions and imaging techniques to easily track and account for impressions recovered in documents using Adobe Photoshop imaging techniques. The presenter will demonstrate how creating layer masks of available writing can be used to account for impressions from multiple documents, remove embossed writing, show their orientation when created, and reveal unsourced impressions in complex documents. This workshop is paced to maximize the amount of time spent working with hands on examples to ensure these techniques can be used when the attendee returns to their work site. Graphic step-by-step walkthrough instructions will be provided for future reference.



We will also need some presenters for the technical session at the fall meeting. If you worked on an interesting case, or used a new technique / new piece of equipment, please consider sharing it with the group during this time. These presentations can be very beneficial and impactful on our close knit QD group and the discipline as a whole. Please feel free to contact me with any questions and acceptance into the workshops will be on a first come basis.
